AGAINST THE CURRENT GOALS AND OBJECTIVES, WE ARE DETERMINED TO EMBARK ON OUR NEW PLANS FOR THE NEXT STRATEGIC PERIOD OF 2023-2028. AL-HAMDULILLAH! THE SUCCESS THAT CAME OUR WAY HAD EMBOLDENED US TO DREAM BIGGER AND BETTER FOR THE COMMUNITY.

THE MOST DEFINING ASPECT OF THE NEW STRATEGY IS OUR PROMISE TO GET OUR OWN SCHOOL AND COMMUNITY CENTRE. MANAGEMENT OF UNIFORM SCHOOL EDUCATION PROGRAMS HAS BEEN A BIG CHALLENGE BEFORE US. WE HAVE STUDENTS STUDYING IN 20-25 DIFFERENT SCHOOLS WITH DIFFERENT BOARDS AND MEDIUMS OF LANGUAGES VIZ. HINDI, URDU, MARATHI AND ENGLISH. FOR THE LAST 25 YEARS, WE HAVE BEEN WORKING ON THIS MODEL, BUT THE COVID-19 PANDEMIC HAS MADE US TO RETHINK ON OUR DECISION. NOT A SINGLE SCHOOL WAS KIND ENOUGH TO CONSIDER OUR REQUEST FOR REBATE OR PARTIAL WAIVER OF THE FEES. BUT, AS PROMISED TO EACH FAMILY, WE ENSURED NOT A SINGLE CANDIDATE WAS DISALLOWED AND MISSED THE SCHOOL EDUCATION AND WE PAID ALL THE FEES BY USING ALL THE AVAILABLE RESOURCES AND FUNDING OPTIONS WE HAD. THIS PANDEMIC HAS TAUGHT US ALL THE LESSONS THAT "WE NEED TO BE RESILIENT TO SUCH SITUATIONS AND PLAN FOR THE NEXT PHASE OF GROWTH PATH". IN THE LONG RUN, OUR NEW STRATEGY WILL PROVIDE US CONTROL OVER OUR COSTS, IN FACT, THIS WILL PROVIDE SAVINGS IN THE FORM OF OUTGOING FEES FUND AND ENABLE US TO PROVIDE A UNIFORM MODE OF EDUCATION TO EACH SCHOOL-GOING CHILD WE SUPPORT TODAY.

AS PART OF THIS STRATEGY, WE HAVE ENVISIONED BELOW 8 'BIG IDEAS'.

1. TO HAVE OUR OWN SCHOOL FOR UNIFORM AND QUALITY EDUCATION AT AFFORDABLE COST BENEFITTING THE WHOLE SOCIETY AT LARGE.
2. NEW ITI AND SKILL DEVELOPMENT PROGRAMS FOR GIRLS, HOUSEWIVES, WIDOWS AND SCHOOL DROPOUTS.
3. ADVANCE COURSES FOR STUDENTS PASSING OUT OF SCHOOLS AND COLLEGES. POST-COMPLETION OF EDUCATION WE PLAN TO GO ONE STEP AHEAD BY HAND-HOLDING THE PASS-OUT STUDENTS TO ENROLL THEMSELVES IN INDUSTRY-ORIENTED COURSES AND 100% JOB PLACEMENTS.
4. PROVIDING HEALTHCARE SERVICES LIKE OPD CONSULTATION, PHYSIOTHERAPY, PATHOLOGY LAB SERVICES, WHEELCHAIR, MEDICAL BEDS AND SUPPORT DEVICES ON A DAILY BASIS AT OUR COMMUNITY CENTERS.
5. CAREER GUIDANCE PROGRAMS AND CONSULTANCY SERVICES.
6. MEMBER ENROLMENT PROGRAM FOR A WELL-KNITTED SOCIETY SPANNING THE OLD AND THE YOUNG GENERATION.
7. TAKE UP DONATION CAMPAIGNS TO PHILANTHROPISTS, CROWDFUNDING PLATFORMS AND CORPORATES BY TAPPING THE CSR FUND.
8. APP DEVELOPMENT AND DIGITAL PRESENCE IN TODAY'S TIME ARE INEVITABLE SO GEO-MAPPING OF EVERY CHILD RECEIVING SUPPORT FROM MARKAZ-E-FALAH IS PLANNED WITH A RE-VERIFICATION PROCESS EVERY 2 YEARS.

WE BELIEVE THAT FOR ANY ORGANIZATION TO GROW FROM STRENGTH TO STRENGTH, IT NEEDS TO BE DYNAMIC AND NURTURING LIKE A FREE-FLOWING RIVER AND THAT IS HOW MARKAZ-E-FALAH IS POISED TO WORK. WE ARE CONSTANTLY STRIVING TO BRING INNOVATION IN EVERYTHING WE DO TO DELIVER THE LASTING CHANGE IN OUR SOCIETY.

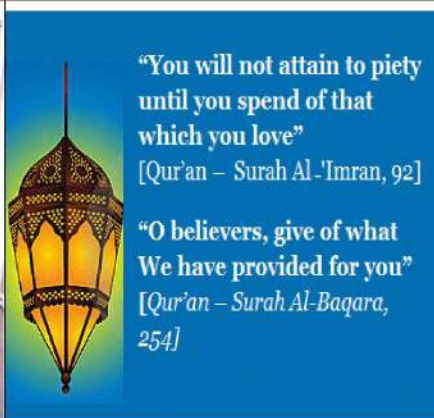
FOOD DISTRIBUTION PROGRAMME

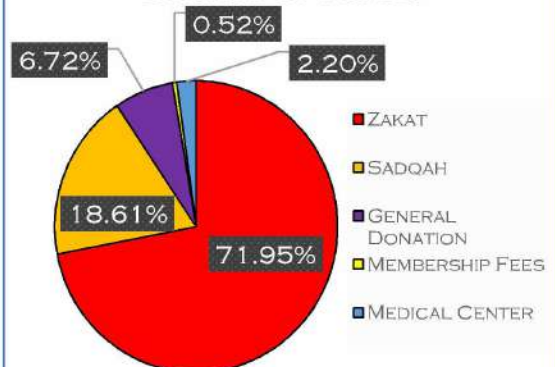
INCOME & EXPENSES (IN MILLION)

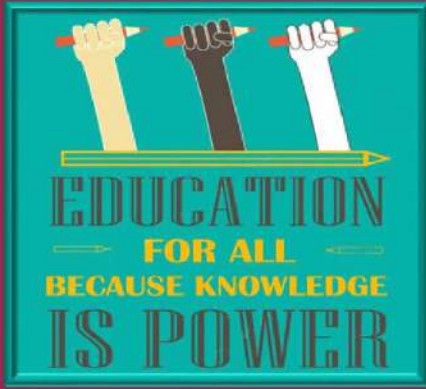

ZAKAT, SADAQAH & WAQF

ISLAM EMPHASIZES THE PRINCIPLES OF SOCIO-ECONOMIC JUSTICE, EQUALITY AND COLLECTIVE PROSPERITY. THROUGH MOBILIZATION OF FUNDS SUCH AS ZAKAT, WAQF AND SADAQAH, IT CAN HELP DELIVER MUCH-NEEDED FINANCING FOR THE HUMANITARIAN CHALLENGES CAUSED IN THE SOCIETY.

ZAKAT — EACH YEAR, MUSLIMS ARE REQUIRED TO DONATE 2.5% OF ONE YEAR'S TOTAL CUMULATIVE WEALTH TO THE POOR IN THE FORM OF ZAKAT. THE ISLAMIC DEVELOPMENT BANK ESTIMATES THE GLOBAL VALUE OF ZAKAT TO BE BETWEEN \$550 BILLION AND \$600 BILLION ANNUALLY.

WAQF — IT IS AN ENDOWMENT TO A RELIGIOUS, EDUCATIONAL OR CHARITABLE CAUSE, MOST FREQUENTLY USED TO BUILD SCHOOLS, HOSPITALS OR RELIGIOUS INSTITUTIONS. GIVEN ITS COMMUNITARIAN NATURE, WAQF IS OFTEN USED TO FUND SOCIAL PROJECTS AND SERVICES.

SADAQAH — IT IS A VOLUNTARY CHARITY GIVEN ON AN AD-HOC BASIS. THINK OF PUTTING COINS INTO A CHARITY DONATION BOX. DUE TO ITS IRREGULAR NATURE, SADAQAH IS OFTEN DIFFICULT TO CALCULATE, BECAUSE IT VARIES FROM INDIVIDUAL TO INDIVIDUAL AND DEPENDS ON THEIR DISPOSABLE INCOME AND LEVEL OF GENEROSITY.

ZAKAT, SADAQAH AND WAQF HAVE ENORMOUS POTENTIAL TO BE LEVERAGED AND SCALED IF USED EFFECTIVELY IN A WELL-ORGANIZED AND DIGITIZED FORM. MARKAZ-E-FALAH HAS TAKEN THIS RESPONSIBILITY TO WORK ON THESE GUIDING PRINCIPLES OF ISLAM AND PLAY ITS ROLE OF BRINGING PEACE, DIGNITY AND IMPARTING QUALITY EDUCATION AND SKILL DEVELOPMENT COURSES FOR SUSTAINABLE LIVELIHOOD PROGRAMS TO EVERY CHILD FROM THE MARGINALIZED AND LESS PRIVILEGED FAMILIES FOR EQUAL PARTICIPATION & STATUS IN THE SOCIETY.
